League Rules

1. Four 10-minute quarters, running clock until last minute of the first three quarters and the last 2 minutes of the fourth quarter.
2. After 5 team fouls in the quarter the offended team will be awarded 2 foul shots. All team fouls will reset each quarter.
3. Size 7 ball will be used.
4. Teams are allowed (3) 30-second timeouts per game. 1 timeout will be added for overtimes.
5. Each overtime will be two minutes.
6. Teams are to be ready for their game at least 30 minutes before the posted game time. If the previous scheduled game finishes early we will start the next game ahead of the scheduled time.
7. Teams will be given a 3-minute halftime.
8. Foul language and inappropriate behavior is not permitted.
9. Each team will need to bring their own basketballs to warm-up. We will not supply basketballs and we will not be responsible for lost balls.
10. All other rules in accordance to PIAA rules.
